4.1 CONDITIONAL USE PERMIT NO. 3123 **REVISION PERMIT NO. 1 and CHANGE OF** ZONE NO. 2100119 – Intent to Adopt a Mitigated **Negative Declaration** – EA42881 – Applicant: Living Free Animal Sanctuary Engineer/Representative: KWC Engineers – Third Supervisorial District - San Jacinto Mountain Zoning Area – REMAP – Open Space-Recreation (OS-R) - Location: The project site is located northerly and easterly of Highway 74, southerly of Highway 243, and westerly of May Valley Road -153.45 Acres – Zoning: Rural Residential-20 Acre Minimum (R-R-20) - REQUEST: A Conditional Use Permit revision for the expansion of the operations of an existing animal sanctuary, Class IV Kennel, Class III cattery and menagerie located on 153.45 gross acres.
