

ORDINANCE NO. 348.3796

AN ORDINANCE OF THE COUNTY OF RIVERSIDE

AMENDING ORDINANCE NO. 348 RELATING TO ZONING

5 The Board of Supervisors of the County of Riverside Ordains
6 as Follows:

7 Section 1. Section 4.2 of Ordinance No. 348, and Official
8 Zoning Plan Map No. 2, as amended, are further amended by placing
9 in effect in the Chuckwalla Area, the zone or zones as shown on
10 the map entitled "Change of Official Zoning Plan Amending
11 Ordinance No. 348, Map No. 2.1900, Change of Zone Case No.6249,"
12 which map is made a part of this ordinance.

13 Section 2. Article XVIIa of Ordinance No. 348 is amended by
14 adding thereto a new Section 17.80 to read as follows:

Section 17.80 SP ZONE REQUIREMENTS AND STANDARDS FOR
SPECIFIC PLAN NO. 305.

a. Planning Area 1.

(1) The uses permitted in Planning Area 1 of Specific Plan No. 305 shall be the same as those uses permitted in Article XIIa, Section 12.50. of Ordinance No. 348, except the uses permitted pursuant to Section 12.50.a., b.(2), and c. shall not be permitted. In addition, the permitted uses identified under Section 12.50.a. shall also include a Non-Hazardous Solid Waste Landfill, as defined by Development Agreement No. 64, the processing of existing fine and coarse tailings and overburden including use of portable materials blender/pugmills and/or rock crushers with or without

related mechanical screening facilities to provide structural fill and cover material for Landfill; maintenance, servicing, and fueling landfill vehicles and equipment; Landfill gas flare and energy recovery facilities; environmental monitoring systems; drainage structures; portable construction offices; portable sanitary facilities; the temporary storage of synthetic liner and construction supplies, materials, and equipment; and the sale and transport of previously mined rock products subject to the obtainment of all applicable regulatory performance standards and requirements, and provided a Site Specific Plot Plan is approved.

(2) The development standards for Planning Area 1 of Specific Plan No. 305 shall be the same as those standards identified in Article XIIa, Section 12.51 of Ordinance No. 348, except the development standards set forth in Section 12.51.d. and e. shall be deleted and replaced by the following:

AA. Structures shall not exceed forty feet (40') at the yard setback line. Buildings shall not exceed fifty feet (50') unless a height up to seventy-five feet (75') is approved pursuant to Section 18.34 of Ordinance No. 348. Structures other than buildings shall not exceed fifty feet (50') unless a height up to one hundred and five feet (105') is approved pursuant to Section 18.34 of Ordinance No. 348. However, Landfill gas flare and

1 energy recovery facilities shall not exceed seventy-
2 five feet (75') unless a greater height is approved
3 pursuant to Section 18.34 of Ordinance No. 348.

4 (3) Any use that is not specifically listed in
5 subsection a.(1) of Section 17.80 of this ordinance may
6 be considered a conditionally permitted or permitted use
7 provided that the Planning Director finds that the
8 proposed use is substantially the same in character and
9 intensity as those listed in the designated subsections.
10 Such a use is subject to the permit process which
11 governs the category in which it falls.

12 (4) Except as provided above, all other zoning
13 requirements shall be the same as those requirements
14 identified in Article XIIa of Ordinance No. 348.

15 b. Planning Area 2.

16 (1) The uses permitted in Planning Area 2 of
17 Specific Plan No. 305 shall be the same as those uses
18 permitted in Article XIa, Section 11.26 of Ordinance No.
19 348, except the uses permitted pursuant to Section 11.26
20 a.; b.; c.; d.; e.; f.; and g. shall not be permitted.
21 In addition, the permitted uses identified under Section
22 11.26.a. shall also include waste container handling
23 facilities; waste container and landfill equipment
24 washing facilities; waste receiving, inspection and
25 sorting facilities for waste generated locally;
26 intermodal rail and truck marshaling yards; Landfill and
27 waste transfer vehicle and equipment maintenance, repair
28 and storage facilities; administrative office buildings,

1 in conjunction with Landfill operations; temporary
2 storage of recyclables and household hazardous waste;
3 drainage structures and facilities; environmental
4 monitoring systems; bentonite, cement and other
5 construction material storage; Landfill gas flare and
6 energy recovery facilities; soil testing laboratories;
7 utility equipment including electrical substations;
8 vehicle/train fueling and above ground storage
9 facilities; and vehicle weighing/scale facilities
10 subject to the obtainment of all applicable regulatory
11 performance standards and requirements, and provided a
12 Site Specific Plot Plan is approved.

13 (2) The development standards for Planning Area 2
14 of Specific Plan No. 305 shall be the same as those
15 standards identified in Article XIa, Section 11.28 of
16 Ordinance No. 348, except the development standards set
17 forth in Section 11.28 b.; c.(3) and (4); d.; e.; f.;
18 g.; h.; i.; and j. shall be deleted and replaced by the
19 following:

20 A. The minimum front, side, and rear yard setback
21 shall be twenty-five feet (25') from the property
22 line.

23 B. Parking areas shall be provided as required by
24 Section 18.12 of Ordinance No. 348 except that the
25 minimum number of off-street parking spaces shall be
26 provided at a ratio of one parking space for every
27 two employees on the largest shift, and one parking
28 space for every two hundred and fifty (250) square

1 feet of gross floor area for office uses, plus one
2 space for each public roadway licensed vehicle used
3 in connection with any permitted use within Planning
4 Area 2 of Specific Plan No. 305.

5 C. Structures other than buildings shall not
6 exceed fifty feet (50') unless a height up to one
7 hundred and five feet (105') is approved pursuant to
8 Section 18.34 of Ordinance No. 348. However,
9 Landfill gas flare and energy recovery facilities
10 shall not exceed seventy-five feet (75') unless a
11 greater height is approved pursuant to Section 18.34
12 of Ordinance No. 348.

13 In addition, the following standards shall also apply:

14 AA. Any parking space provided for semi-trucks
15 and trailers shall have a minimum size of twelve
16 feet (12') by forty feet (40').

17 BB. There shall be no development activity within
18 those areas with natural topography which exceed
19 twenty-five percent (25%) slopes.

20 (3) Any use that is not specifically listed in
21 subsection b.(1) of Section 17.80 of this ordinance may
22 be considered a conditionally permitted or permitted use
23 provided that the Planning Director finds that the
24 proposed use is substantially the same in character and
25 intensity as those listed in the designated subsections.
26 Such a use is subject to the permit process which
27 governs the category in which it falls.

28 (4) Except as provided above, all other zoning

1 requirements shall be the same as those requirements
2 identified in Article XIa of Ordinance No. 348.

3 c. Planning Area 3.

4 (1) The uses permitted in Planning Area 3 of
5 Specific Plan No. 305 shall be the same as those uses
6 permitted in Article XIa, Section 11.26 of Ordinance No.
7 348, except the uses permitted pursuant to Section 11.26
8 a.; b.; c.; d.; e.; f.; and g. shall not be permitted.
9 In addition, the permitted uses identified under Section
10 11.26.a. shall also include waste container handling
11 facilities; waste container and landfill equipment
12 washing facilities; waste receiving, inspection, and
13 sorting facilities for waste generated locally;
14 intermodal rail and truck marshaling yards; Landfill and
15 waste transport vehicle and equipment maintenance,
16 repair, and storage facilities; administrative office
17 buildings, in conjunction with Landfill operations;
18 temporary storage of recyclables and household hazardous
19 waste; drainage structures and facilities; water storage
20 tanks; septic sewage systems; Landfill gas flare and
21 energy recovery facilities; utility equipment;
22 vehicle/train fueling and above ground fuel storage
23 facilities; vehicle weighing/scale facilities; and
24 environmental monitoring systems subject to the
25 obtainment of all applicable regulatory performance
26 standards and requirements, and provided a Site Specific
27 Plot Plan is approved.

28 (2) The development standards for Planning Area 3

1 of Specific Plan No. 305 shall be the same as those
2 standards identified in Article XIa, Section 11.28 of
3 Ordinance No. 348, except the development standards set
4 forth in Section 11.28 b.; c.(3) and (4); d.; e.; f.;
5 g.; h.; i.; and j. shall be deleted and replaced by the
6 following:

7 A. The minimum front, side, and rear yard setback
8 shall be twenty-five feet (25') from the property
9 line.

10 B. Parking areas shall be provided as required by
11 Section 18.12 of Ordinance No. 348 except that the
12 minimum number of off-street parking spaces shall be
13 provided at a ratio of one parking space for every
14 two employees on the largest shift, and one parking
15 space for every two hundred and fifty (250) square
16 feet of gross floor area for office uses, plus one
17 space for each public roadway licensed vehicle used
18 in connection with any permitted use within Planning
19 Area 3 of Specific Plan No. 305.

20 C. Structures other than buildings shall not
21 exceed fifty feet (50') unless a height up to one
22 hundred and five feet (105') is approved pursuant to
23 Section 18.34 of Ordinance No. 348. However,
24 Landfill gas flare and energy recovery facilities
25 shall not exceed seventy-five feet (75') unless a
26 greater height is approved pursuant to Section 18.34
27 of Ordinance No. 348.

28 In addition, the following standards shall also apply:

1 AA. Any parking space provided for semi-trucks
2 and trailers shall have a minimum size of twelve
3 feet (12') by forty feet (40').

4 BB. There shall be no development activity within
5 those areas with natural topography which exceed
6 twenty-five percent (25%) slopes.

7 (3) Any use that is not specifically listed in
8 subsection c.(1) of Section 17.80 of this ordinance may
9 be considered a conditionally permitted or permitted use
10 provided that the Planning Director finds that the
11 proposed use is substantially the same in character and
12 intensity as those listed in the designated subsections.
13 Such a use is subject to the permit process which
14 governs the category in which it falls.

15 (4) Except as provided above, all other zoning
16 requirements shall be the same as those requirements
17 identified in Article XIa of Ordinance No. 348.

18 d. Planning Area 4.

19 (1) The uses permitted in Planning Area 4 of
20 Specific Plan No. 305 shall be the same as those uses
21 permitted in Article XIIa, Section 12.50. of Ordinance
22 No. 348, except the uses permitted pursuant to Section
23 12.50.a., b., and c. shall not be permitted. In
24 addition, the permitted uses identified under Section
25 12.50.a. shall also include storage of equipment and
26 recyclable materials in intermodal shipping containers;
27 drainage structures and settling basins; Landfill gas
28 flare and energy recovery facilities; environmental

1 monitoring systems; and rail spurs subject to the
2 obtainment of all applicable regulatory performance
3 standards and requirements, and provided a Site Specific
4 Plot Plan is approved.

5 (2) The development standards for Planning Area 4
6 of Specific Plan No. 305 shall be the same as those
7 standards identified in Article XIIa, Section 12.51 of
8 Ordinance No. 348, except the development standards set
9 forth in Section 12.51.d. and e. shall be deleted and
10 replaced by the following:

11 A. Intermodal shipping containers shall not be
12 stacked so as to exceed thirty feet (30') in
13 height. In addition, no building or structure shall
14 exceed fifty feet (50') in height, unless a height
15 up to seventy-five feet (75') for buildings or one
16 hundred five feet (105') for other structures is
17 specifically permitted under the provisions of
18 Section 18.34 of Ordinance No. 348.

19 (3) Any use that is not specifically listed in
20 subsection d.(1) of Section 17.80 of this ordinance may
21 be considered a conditionally permitted or permitted use
22 provided that the Planning Director finds that the
23 proposed use is substantially the same in character and
24 intensity as those listed in the designated subsections.
25 Such a use is subject to the permit process which
26 governs the category in which it falls.

27 (4) Except as provided above, all other zoning
28 requirements shall be the same as those requirements

1 identified in Article XIIa of Ordinance No. 348.

2 e. Planning Area 5.

3 (1) The uses permitted in Planning Area 5 of
4 Specific Plan No. 305 shall be the same as those uses
5 permitted in Article XIIa, Section 12.50. of Ordinance
6 No. 348, except the uses permitted pursuant to Section
7 12.50.a., b., and c. shall not be permitted. In
8 addition, the permitted uses identified under Section
9 12.50. shall also include excavating, processing and
10 transporting of fine and coarse tailing and overburden,
11 including use of portable or stationary materials
12 blender/pugmills and/or rock crushers with or without
13 related mechanical screening facilities to provide
14 structural fill and cover material for Landfill; water
15 reservoirs; drainage structures and settling basins;
16 Landfill gas flare and energy recovery facilities; and
17 environmental monitoring systems subject to the
18 obtainment of all applicable regulatory performance
19 standards and requirements, and provided a Site Specific
20 Plot Plan is approved.

21 (2) The development standards for Planning Area 5
22 of Specific Plan No. 305 shall be the same as those
23 standards identified in Article XIIa, Section 12.51 of
24 Ordinance No. 348, except the development standards set
25 forth in Section 12.51.d. and e. shall be deleted and
26 replaced by the following:

27 AA. Structures shall not exceed forty feet (40')
28 at the yard setback line. Buildings shall not

1 exceed fifty feet (50') unless a height up to
2 seventy-five feet (75') is approved pursuant to
3 Section 18.34 of Ordinance No. 348. Structures
4 other than buildings shall not exceed fifty feet
5 (50') unless a height up to one hundred and five
6 feet (105') is approved pursuant to Section 18.34 of
7 Ordinance No. 348. However, Landfill gas flare and
8 energy recovery facilities shall not exceed seventy-
9 five feet (75') unless a greater height is approved
10 pursuant to Section 18.34 of Ordinance No. 348.

11 (3) Any use that is not specifically listed in
12 subsection e.(1) of Section 17.80 of this ordinance may
13 be considered a conditionally permitted or permitted use
14 provided that the Planning Director finds that the
15 proposed use is substantially the same in character and
16 intensity as those listed in the designated subsections.
17 Such a use is subject to the permit process which
18 governs the category in which it falls.

19 (4) Except as provided above, all other zoning
20 requirements shall be the same as those requirements
21 identified in Article XIIa of Ordinance No. 348.

22 f. Planning Areas 6a, 6b, 6c, 6d, and 6e.

23 (1) The uses permitted in Planning Areas 6a, 6b,
24 6c, 6d and 6e of Specific Plan No. 305 shall be the same
25 as those uses permitted in Article VIIIE, Section 8.100.
26 of Ordinance No. 348, except the uses permitted pursuant
27 to Section 8.100.a. and b. shall not be permitted. In
28 addition, the permitted uses identified under Section

1 8.100. shall also include undeveloped open space;
2 drainage structures and settling basins; existing
3 facilities for the storage and distribution of water or
4 replacement thereof; and environmental monitoring
5 systems subject to the obtainment of all applicable
6 regulatory performance standards and provided a Site
7 Specific Plot Plan is approved.

8 (2) There shall be no development standards for
9 Planning Areas 6a, 6b, 6c, 6d, and 6e of Specific Plan
10 No. 305.

11 (3) Any use that is not specifically listed in
12 subsection f.(1) of Section 17.80 of this ordinance may
13 be considered a conditionally permitted or permitted use
14 provided that the Planning Director finds that the
15 proposed use is substantially the same in character and
16 intensity as those listed in the designated subsections.
17 Such a use is subject to the permit process which
18 governs the category in which it falls.

19 (4) Except as provided above, all other zoning
20 requirements shall be the same as those requirements
21 identified in Article VIIIE of Ordinance No. 348.

22 g. Site Specific Plot Plan. The term Site Specific
23 Plot Plan as used in this zoning ordinance for Specific Plan
24 No. 305 shall mean a plot plan reviewed and approved in
25 accordance with Section 3.5 of Development Agreement No. 64
26 which section is hereby incorporated as though fully set
27 forth.

1 Section 3. This ordinance shall take effect 30 days after
2 its adoption or the date Resolution No. 97-236 becomes effective,
3 whichever is later; provided, however, it shall not be operative
4 until the Effective Date as that term is defined in Development
5 Agreement No. 64.








