

V. PLANNING AREAS 22A, 22B, 22C AND 22D: DETENTION BASINS

1.0 DESCRIPTIVE SUMMARY

Planning Areas 22A, 22B, 22C and 22D, as shown on Figures 4-2, 4-3 and 4-4, provide for the development of 10.5, 7.1, 5.5, and 17.9 acres (respectively) of open space to serve as detention basins for the community's storm water runoff. Passive parks and trails may be integrated within detention basin areas to provide additional opportunities for recreation within the TRAILMARK community.

	As shown in Figure 5-21, <i>Monument Master Plan</i> , trail monuments shall be located within these planning areas, as illustrated in Figure 5-28, <i>Park</i> , <i>Equestrian Staging</i> , and <i>Trail Monumentation</i> .			
	An interface shall be provided between the detention basins and residential planning areas, as depicted in Figure 5-59, <i>Residential/Detention Basin Interface</i> .			
	A naturalized detention basin shall be provided in Planning Area 22C, as depicted on Figure 5-57, <i>Detention Basin Concept Plan - Planning Area 22C</i> .			
	A detention basin / passive park shall be provided in Planning Area 22D, as depicted on Figure 5-58, <i>Detention Basin / Passive Park Concept Plan - Planning Area 22D</i> .			
	Trails shall be provided as depicted on Figure 5-63. <i>Trails Concept Plan</i> .
