## General Plan Amendment No. 960 and Climate Action Plan: General Plan Update (EIR No. 521 / SCH 2009041065)



Riverside County has prepared a Revised General Plan document that will be going to public hearings in the coming months. Some of the revisions affect countywide policies and some affect specific parcels. The amended General Plan Update documents, maps and data can be viewed online on the County Planning Department's website at http://planning.rctlma.org.



The next step in the General Plan Update process is the public outreach meetings located throughout the County. These meetings will clarify the purpose of a general plan and explain the changes proposed by GPA No. 960. The meetings, which will be held in an informal, townhall format, will allow residents to preview the draft documents and address plan related questions to County staff. Following the outreach meetings, the GPA No. 960, DEIR No. 521 and Climate Action Plan will be the subject of several formal public hearings before the Planning Commission in August and the Board of Supervisors later this year. Everyone in the Community is encouraged to participate in the public outreach meetings and the subsequent public hearing process.
