General Plan Certainty System


- Administration Element required a 5-year update (now 8) and provides guidance to implement a Certainty System that strikes balance between:

 - Flexibility in their implementation





Changing Times (2000 – 2010)





- SR-79: expansion of N/S travel in Hemet/San Jacinto area, realign between Domenigoni Pkwy and Gilman Springs Rd.







Specific Area Plan Updates Proposed By GPA No. 960 Eastern Coachella Valley AP

 Removes Chiriaco Summit Rural Village Overlay from map, land uses already addressed in Planned Communities Policy Area

Elsinore AP

NING DEPARTMENT

- Eliminates El Cariso Village RVO Study Area due to limited access, infrastructure capacity and GPA No. 1075
- Adds Meadowbrook RVO, allows uses higher in intensity than the underlying LUDs
- Modifies Lake Elsinore Environs Policy area to reflect 100year flood hazard zone, id. parcels appropriate for commercial, encourage clustering, preserve historic character of Lakeland Village



Specific Area Plan Updates Proposed By GPA No. 960

Lakeview/Nuevo AP

- Adds Northeast Business Park Overlay to allow ag uses to allow landowners to transition from ag to more urban uses and address future jobs/housing balance for this region
- Adds Lakeview Mountains Policy Area to guide future growth, implement concepts of "new urbanism" and healthy communities while striking a balance with conserved lands to the north

Mead Valley AP

 Creates Good Hope RVO from existing 2003 RVO Study Area, allows uses higher in intensity than the underlying LUDs



Specific Area Plan Updates Proposed By GPA No. 960 San Jacinto AP

 Eliminates 2003 Agriculture/Potential Development Special Study Area, focused analysis concluded that 7,664 acres should continue to grow according underlying agricultural LUDs

Riverside Extended Mountain AP


- Eliminates 2003 Aguanga RVSA, focused analysis concluded that 6,370 acres should continue to grow according underlying LUDs due to limited access and infrastructure
- Dissolves 2003 Anza Valley RVO due to limited infrastructure, area incorporate into new 75,500 acre Anza Policy Area, to develop per Anza Valley Vision and Goals endorsed by Board and MAC



Specific Area Plan Updates Proposed By GPA No. 960

Western Coachella Valley AP

 Analyzes existing Sky Valley RVO, finds it to be appropriate for the community, determined no change necessary





Parcel-Specific Land Use Changes Proposed By GPA No. 960

Conserved Land Mapping Changes

 Changes LUDs for approx. 14,800 acres to Open Space-Conservation Habitat (OS-CH)

Criteria-Based Parcel Specific Land Use Changes (8 categories)

- 1. <u>Technical Errors</u>: corrects 78 acres erroneously designated Rural Mountainous
- Open Space-Conservation Habitat Designation Changes: corrects 3,261 acres of private land erroneously designated as OS-CH (used to designate public lands)
- 3. <u>Public Facilities Designation Changes</u>: corrects 192 acres of privately-owned land erroneously slated for public benefit



Parcel-Specific Land Use Changes Proposed By GPA No. 960

- <u>Open Space Conservation</u>: corrects 28 acres originally designated OS-C in 2003 but found to be unsuitable for such
- <u>Open Space-Recreation Changes</u>: corrects 38 acres originally designated as OS-R in 2003 but not appropriate for such uses
- 6. <u>Appropriate Designation for Public Use Lands</u>: correctly designates 777 acres of lands planned for public facilities and open space uses
- <u>Designations Appropriate for Existing Lot Sizes</u>: corrects LUD for 11 acres which do not support the LUD given in 2003 for the subject lot size



Parcel-Specific Land Use Changes Proposed By GPA No. 960

 Other Land Use Changes: addresses LUDs identified by Planning Director since 2003 that do not fit into other categories above including 782 acres of fish farming, aquaculture and related activities under the Agriculture (AG) LUD. Encompasses 2,350 acres.

EIR No. 521

- Updated to better reflect the existing conditions within the County
- Several analysis sections of EIR were further refined to reflect changes associated with updated background information
- All analysis sections were updated where relevant to maintain consistency with GPA960 and Climate Action Plan

- Updated with new implementation measures





- Preserve local land use control over how greenhouse gas reductions are accomplished within the unincorporated County areas.
- Provide local control over how AB 32 is implemented within the County.
- Streamline the CEQA analysis process for future development projects within the County.
- Implement the actions within the plan in a way that increases the ability of the County to attract businesses and development.





Greenhouse Gas Reductions

- Review and account for State regulations that will reduce GHG emissions within the Unincorporated County areas.
- Review and account for existing codes, policies, and programs that will reduce GHG emissions within the Unincorporated County areas.
- Assess additional reductions needed to achieve the AB32 compliant Reduction Target
- Provide Screening Tables as a better, faster, more fiscally prudent approach in determining reductions needed from development projects.

 - Keep the development review process of GHG emission reductions flexible through a menu of options
 - Provide proportionality and fair share contribution
